We hope to see you all at ACS CAN's 2016 Idaho Day at the Capitol on January 30, 2017.



2016 ACS CAN Leadership Summit & Lobby Day

In September, 700 ACS CAN volunteers leaders from all 50 states attended the annual ACS CAN Leadership Summit and Lobby Day in Washington DC.

This year, the Idaho volunteers' efforts led to some great "wins".

Representative Mike Simpson agreed to sign on as a cosponsor to a bill that would close the Medicare loophole on colonoscopy screenings, and he agreed to continue to support increases in cancer research funding. Representative Simpson was the keynote speaker at Idaho's 2016 Cancer Research Breakfast in October and announced he would also be signing on as a cosponsor for the Palliative Care Hospice Education and Training Act (PCHETA). We couldn't have done it without everyone's emails to our elected officials in Congress. Thank you!
