As 2020 comes to an end

and we prepare for the 2021 legislative upcoming session, the Hawaii Pacific volunteer and staff team will continue the fight to end cancer for the people of Hawaii and across the nation. We recognize that the coming year will continue to have unique challenges as we operate in a mostly virtual world, but know that cancer never stops so neither will we.



With this said, we need your help more than ever with these legislative priorities:

- Tobacco Control and Prevention: The Centers for Disease Control (CDC) Youth Risk Behavior Survey released in the summer of this year found that we are losing ground in the fight to protect our keiki from a potential lifetime addiction to tobacco. E-cigarette use among high school students in Hawai'i has increased by 5%. In order to prevent initiation and promote cessation, ACS CAN is advocating to ensure that all forms of tobacco products including electronic smoking devices are regulated including taxation at the same rate as cigarettes, licensing of all tobacco retailers for tax collection and enforcement.
- Protect and maintain current programs that support our mission of cancer prevention, research and access to care. As the state government is facing a large budget shortfall next year, programs that support and benefit cancer patients and caretakers may be in jeopardy. ACS CAN will stay vigilant to protect the funding including cancer research and tobacco cessation programs.

We need your help! Your ACS CAN team will keep you updated with any legislative developments, but we need your help. Can we count on you to get involved and take action to continue the fight to end cancer for the people of Hawaii and across the nation? This year we plan to host a volunteer advocacy training, conduct a virtual Cancer Action Day (previously known as Day at the Capitol) and we will be seeking testimonies on various cancer related bills. Cancer Screen Week

Cancer Screen Week which took place between December 7-11 of this year was particularly important. More than one-third of people living in the U.S. have missed routine cancer screenings due to COVID-19, potentially leading to many cancers undetected. Prevention and early detection are critical to our mission.

This year alone, there were nearly 1 million fewer mammograms, colorectal cancer screenings, and cervical cancer screenings, compared to previous years. The COVID-19 pandemic has worsened potential social determinants of health by creating additional challenges, such as unemployment, potential delays for health appointments, or being at higher risk of COVID-19 infection or complications.
