### EQUITABLE ACCESS **TO CLINICAL TRIALS**



Congress unanimously passed the Henrietta Lacks Enhancing Cancer Research Act to identify federal policy barriers to clinical trial enrollment faced by traditionally underrepresented groups, including communities of color.

### **INCREASE IN FEDERAL** RESEARCH FUNDING

Leading the cancer advocacy community, ACS CAN influenced passage of a bipartisan funding bill that included a \$1.25 billion increase in medical research funding at the National Institutes of Health, including a nearly \$120 million increase

for the National **Cancer Institute.**

ACS CAN helped secure and protect nearly \$1.4 billion in appropriations at the state and local levels, including \$795 million to fund lifesaving tobacco prevention and cessation programs.
