

2022 South DakotaLegislative Priorities

Victory in the fight against cancer requires bold new public policies that promote cancer prevention, early detection of cancer, and expand access to quality, affordable health care. Lawmakers make many decisions that impact the lives of South Dakotans touched by cancer and their leadership is vital to defeating this disease.

In 2022, in light of the COVID-19 pandemic, the American Cancer Society Cancer Action Network (ACS CAN) will work with the South Dakota Legislature on legislative and regulatory efforts that address disruption in cancer care and screenings; provide affordable, adequate access to health care insurance including Medicaid; as well appropriations funding for lifesaving cancer screening and prevention policies that help people that use tobacco products quit and deter kids from ever using tobacco products. We will be making the following evidence-based policies a priority and ask for your support:

Ensuring Access to Quality Care

- Medicaid Expansion: ACS CAN will advocate for low-income individuals and families to have access
 to health insurance coverage through state Medicaid programs. We will support policies that
 preserve funding and access to Medicaid for low-income parents and adults and will advocate for
 Medicaid expansion in states that have not increased eligibility up to 138 percent of the federal
 poverty level.
- Affordable, Adequate Health Insurance: ACS CAN will advocate for policies that ensure access to quality, affordable and comprehensive health insurance and will support efforts to curb the availability of inadequate health plans.
- Network Adequacy: ACS CAN will support legislation regarding health insurance network adequacy
 to help ensure that cancer patients and cancer survivors have access to appropriate medical
 specialists they may need.
- Reduce Barriers to Clinical Trials: ACS CAN supports legislation to ensure Medicaid covers routine
 care costs for eligible Medicaid enrollees to participate in cancer clinical trials. Ensuring state
 Medicaid programs cover routine care costs for eligible clinical trials will bring Medicaid in line with
 requirements for Medicare and most private insurance plans and can improve research by increasing
 diversity among clinical trial participants.

Cancer Prevention and Early Detection

- Breast and Cervical Cancer: ACS CAN will advocate to increase funding for All Women Count!, the state breast and cervical cancer screening program for low-income uninsured and underinsured women administered by the South Dakota Department of Health.
- Colorectal Cancer: ACS CAN will work to establish funding for colorectal cancer screening, treatment, and patient navigation programs. Additionally, ACS CAN will work to ensure health plans cover colorectal cancer screening beginning at age 45 in accordance with updated American Cancer Society guidelines and ensure patients are not charged for colonoscopies that follow a positive stool-based test.

Reducing the Toll of Tobacco

- **Tobacco Prevention and Cessation Funding:** ACS CAN will work to fund and sustain evidence-based, statewide tobacco use prevention and cessation programs at \$4.5 million.
- Access to Tobacco Cessation: ACS CAN will advocate for all insurance plans, including the state
 Medicaid program, to provide a comprehensive cessation benefit that covers individual, group,
 and telephone counseling and all FDA-approved tobacco cessation medications without costsharing or other barriers to accessing care.
- **Smoke-Free Air:** ACS CAN will work to defend the statewide comprehensive smoke-free law that includes all restaurants, bars, gaming facilities, and non-hospitality workplaces.
