

# **State Legislative Priorities**

#### **Tennessee 2025 Legislative Asks**

#### **Biomarker Testing**

Please support HB484/SB435 to increase access to biomarker testing.

2 JUUL Funds Ensure all JUUL settlement dollars go to the Tobacco Use Prevention and Control Program under the Tennessee Department of Health.





#### **Issue Overview: JUUL Funds**


- This funding should be invested in the health of Tennessee's youth who were targeted by JUUL.
- The ongoing impact of tobacco addiction requires continued and robust efforts to advance fact-based tobacco control policies.
- Tobacco companies spend \$280.3 million in Tennessee on tobacco marketing annually. As Big Tobacco has been working hard to addict future generations with e-cigarettes and other tobacco products, the need for funding for tobacco prevention programs has never been greater.
- Over 21% of Tennessee high school students use e-cigarettes, compared to 7.8% nationally.






# **Biomarker Testing**

### Precision Medicine with Biomarker-Informed Treatment Selection





#### **Barriers: Insurance**

#### Coverage of tests differs greatly across payers

• Coverage policies generally more common for single-gene tests vs. multi-gene panel tests

#### Plans aren't necessarily following the evidence

- A recent paper in *Personalized Medicine* highlights gaps between insurance coverage and clinical practice guidelines.
- Although 91% of plans evaluated reference NCCN treatment guidelines in their biomarker testing policies, 30% under the largest insurer in Tennessee are "more restrictive" than these guidelines for biomarker testing in breast, non-small cell lung cancer, melanoma and/or prostate cancer patients.

#### **Legislation to Address Coverage Gaps**

#### Requires state-regulated insurance plans including TennCare Medicaid to cover comprehensive biomarker testing when supported by medical and scientific evidence

Biomarker testing must be covered for the purposes of diagnosis, treatment, appropriate management, or ongoing monitoring of an enrollee's disease or condition when the test is supported by medical and scientific evidence, including, but not limited to:

- 1. Labeled indications for an FDA-approved or -cleared test
- 2. Indicated tests for an FDA-approved drug;
- 3. Warnings and precautions on FDA-approved drug labels
- 4. Centers for Medicare and Medicaid Services (CMS) National Coverage Determinations and Medicare Administrative Contractor (MAC) Local Coverage Determinations; or
- 5. Nationally recognized clinical practice guidelines and consensus statements.

### Disease and stage agnostic, establishes prior authorization timelines

#### How will increasing coverage of appropriate biomarker testing help?

 Biomarker testing helps connect patients with the most effective treatment for their cancer and avoid treatments that will be ineffective.

Currently, most plans cover some biomarker testing for some patients.

Without action to improve access to biomarker testing, some patients will be left behind from the latest advancements in treatment.


 Personalized treatments are helping cancer patients live longer and better.

- Legislation applies to state-regulated insurance plans, including Medicaid
- Disease & stage agnostic

Biomarker testing should be covered and reimbursed by public and private payers when supported by clinical practice guidelines or peer-reviewed scientific evidence.



#### Legislation to Expand Access to Biomarker Testing

#### Introductions

Meeting leader introduces the group - the leader in each meeting should be a constituent!

### Who you are, where you're from (be specific!)

Who else is in your group





#### Line

#### Craft your story:

- You know your passion
- You know your cancer connection
- You know the ASK
- You have your talking points

#### Tell your personal story:

- Connect your story to the importance of the ASKS
- Explain the need: why this is needed/impact on state/why important for cancer etc.)







#### Make the ASKs

#### Secure a response from the lawmaker





#### Hook, Line, Sinker



### Meeting leader introduces the group (name + where you live) and why you are here.

I am here as a volunteer for ACS CAN. We are meeting with nearly every Member of the Tennessee Legislature.
