Thank you for your continued leadership and commitment to New Yorkers during this unprecedented time. Sadly, the pandemic has highlighted health disparities that continue to grow throughout the country where policies have continued to disenfranchise the poor, communities of color, and rural residents.

At this critical moment, we must keep our communities healthy and safe, which means building strong public health infrastructure through evidence-based interventions demonstrated to decrease health disparities in our communities. **Pharmacists are a key partner in building this strong health infrastructure.** 

As public health, clinical and civic organizations we strongly urge the final budget include language to allow pharmacists to administer all vaccines approved by the CDC's Advisory Committee on Immunization Practices (ACIP).

More and more, consumers are turning to their local pharmacy for medical information, advice and services. Pharmacists are some of the most trusted health care professionals and important members of the state's health care system.

More than 90% of the nation's population live within two miles of a community pharmacy and over 95% live within five miles. Pharmacies traditionally have longer hours of operation making them more accessible for many for vaccination services. Expanding access will assist countless New Yorkers and remove barriers to vaccinations.

Thank you for all your work over the last year to keep residents of New York safe during this the public health emergency. We strongly encourage the Assembly to support allowing pharmacists to administer approved vaccines and to include this provision in the state's final budget.
