October Meeting Date and Topic: Our next volunteer meeting will be October 28 at 7pm. We'll be sharing updates then splitting into teams to talk about state specific outreach to new and returning lawmakers post election.

Candidate Meeting Reminders: In September we talked about ways you can do

research on your elected official or candidates in your area, and asked you to attend Town Halls or set up virtual meetings with candidates to share with them the work of ACS CAN and find out where they stand on priority issues. These two action items are great things that all volunteers can continue between now and November 3!

ACS Real Men Wear Pink: ACS is in the middle of fundraising for the Making Strides Against Breast Cancer event, and have an opportunity you might be interested in. We are looking for volunteers (men or youth of any gender) to commit to raising \$2,500 for ACS, promote the ACS mission on social media, and wearing pink every day in October. ResearchHERS Update: ResearcHers is a movement that shines a light on the incredible discoveries made be women and empowers women leaders to support the ACS's national research program, which funds some of the brightest female minds in cancer research. Simply put, it is fundraising by women, to support women-led research. Currently half of ACS's research grantees are women, with most of them early in their careers. Important to note, funds raised through this campaign will not be restricted to a particular cancer type, specific research project or a specific geographic region. All funds generated will support women-led research across all geographies and will support grants that provide the most promise for accelerating the fight against cancer.

We are currently looking to identify female ambassadors to support this campaign. These should be women with a network of support, who are able to commit to the personal fundraising goal of \$2500. - On October 26 at 3pm, ACS CAN will convene stakeholders in federal cancer research funding to discuss the impact of COVID-19 on research, and the work needed to reignite cancer research. Dr. Ned Sharpless, Director of the National Cancer Institute will be joining us. ACS CAN will also be recognizing Senator John Keenan and Representative Danielle Gregoire for their work on passing first in the nation tobacco flavors ban legislation.
- Goal is \$400,000 and we're currently at \$310,000
