ADA Parking:

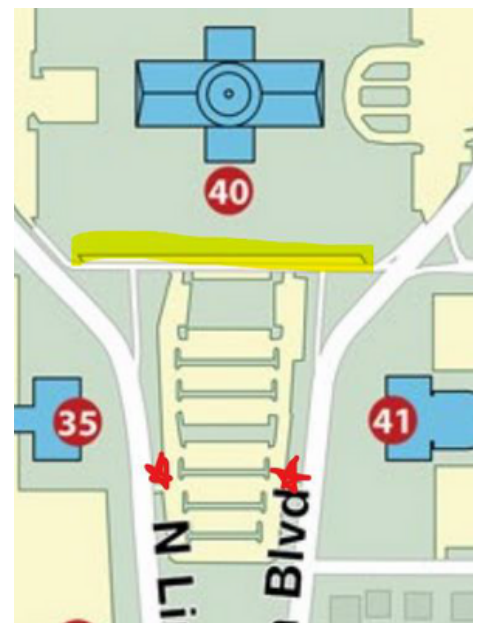
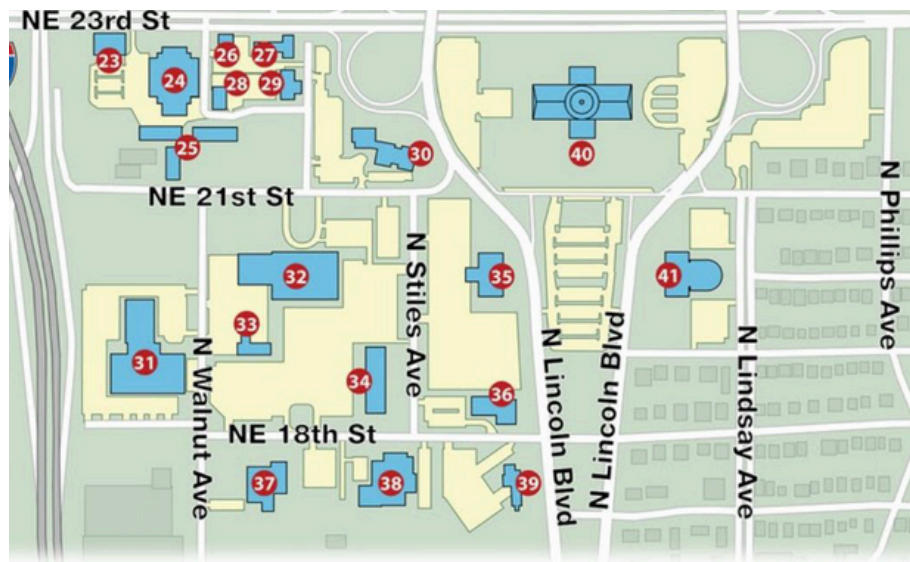
Please park on the south side of the Capitol. Accessible parking is located at the base of the south steps. Overflow parking is available at the Jim Thorpe Building west of Lincoln Blvd.

The visitor entrance which is located on the southeast corner of the Capitol is ADA accessible.

The road that runs along the south side of the Capitol has the majority of ADA parking that is most accessible by the public.

The visitor entrance is downhill from parking so be prepared for some long ramps.

Pick up at step # 4 in the Visitor Parking Guide on the next page.

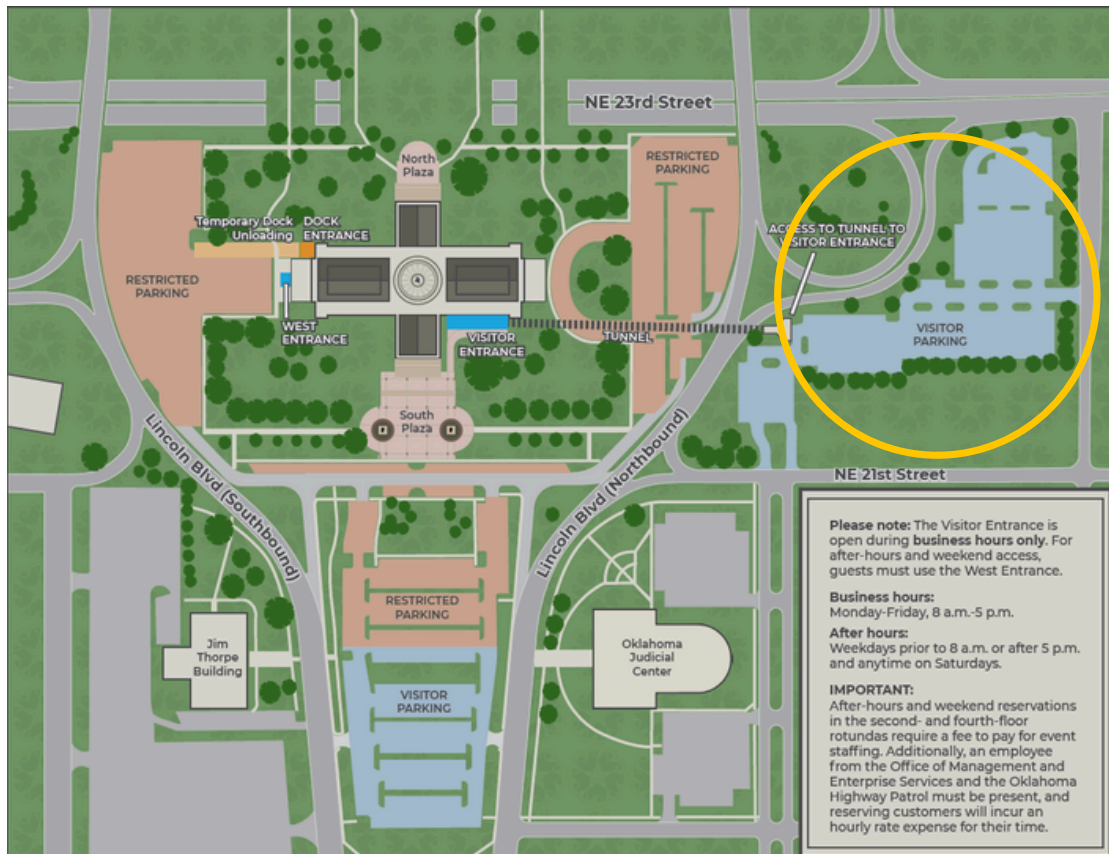

1. Please park in the East visitor parking lot (pictured below and circled in yellow)
Please Note: East Visitor Parking Lot is not ADA friendly.



2. Once parked, enter the East Tunnel Entrance (pictured below)

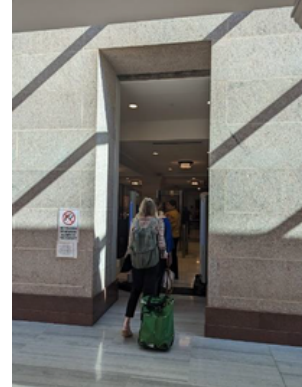
Oklahoma Capitol Map: Visitor Directions



3. Continue straight through the tunnel until you reach the security checkpoint on the right.

For security checkpoint:

- - No firearms or weapons are allowed.
- - If you have a purse, keep your keys and phone in it.
- - If you do not have a purse, security will provide a bowl to put these in.



4. Once through the checkpoint, restrooms are straight ahead next to the gift shop/information center.

- We will provide coffee and breakfast, however if you would like any additional food/drink, Bee Healthy Café is directly around the corner from the gift shop.

5. Take the elevator directly to the left of the gift shop.

- Go to the 5th Floor

6. Take a right directly out of the elevator and walk to the end of the hall.

- Our room is directly to the right of the stairs at the end of the hall.

You'll see our smiling faces when you get there!
