

## Impact of Tobacco in Oklahoma: The Need to Increase Tobacco Taxes to Reduce Healthcare Costs, Protect Kids, and Save Lives

## **Health & Economic Costs of Tobacco to Oklahoma**

Tobacco is an addictive and deadly product. Smoking harms nearly every organ in the body<sup>i</sup> and remains the number one cause of preventable death. In Oklahoma:

- 15.8% of adults smoke cigarettes."
- 23.4% of high school students use tobacco products including 4.3% who smoke cigarettes, 21.8% who use e-cigarettes, 6.2% who smoke cigars, and 3.8% who use smokeless tobacco.
- 34.2% of cancer deaths are caused by smoking. iv
- 89% of Oklahoma voters agree that tobacco use has a significant impact on the health of Oklahomans.
- Smoking is estimated to cost Oklahoma \$1.88 billion in direct health care costs, including \$283.8 million in Medicaid costs annually.vi
- Smoking costs the state \$4.6 billion in productivity costs annually.
- On average, Oklahoma residents pay \$1,113 per household in state and federal taxes from smoking-caused government expenditures, whether they smoke or not.

## **Everyone Benefits from Tobacco Tax Increases**

ACS CAN calls on Oklahoma lawmakers to increase the cigarette tax by \$1.50 per pack and tax all other tobacco products in parity with cigarettes to reduce health care costs, protect kids, and save lives. Regular and significant tobacco tax increases have a meaningful, measurable track record of success for states.

- Save Lives: Significant tobacco tax increases are one of the most effective ways to prevent kids from starting to use tobacco and help adults quit. ix,x Increasing Oklahoma's cigarette tax by \$1.50 per pack would prevent 4,800 kids from becoming adults who smoke, help 13,500 adults who smoke quit, and save 4,700 lives. xi
- Save Money: Substantial increases in cigarette tax rates not only save lives, but it also generates significant increases in new revenue. In fact, every state that has significantly increased its cigarette tax has also boosted its state revenue. Additionally, significant tobacco tax increases reduce healthcare costs. Increasing Oklahoma's cigarette tax by \$1.50 per pack would generate \$111.39 million in new annual revenue for the state as well as provide \$243.65 million in long-term health care cost savings from adult and youth smoking declines.
- Voters Approve: 67% of Oklahoma voters support increasing the tax on cigarettes and all other tobacco products.\*\*

Together we can create a cleaner, safer, healthier Oklahoma by significantly increasing tobacco taxes on all forms of commercial tobacco products.
