Dear Senate and House Leadership and Committee Chairs and Ranking Members:

On behalf of over 520 leading national, state, and local advocacy organizations endorsing H.R. 2407 (the Nancy Gardner Sewell Medicare Multi-Cancer Early Detection Screening Coverage Act) and S. 2085 (the Medicare Multi-Cancer Early Detection Screening Coverage Act), we are writing to respectfully urge you to advance this policy through the legislative process and pass it this year.

H.R. 2407 and S. 2085 have just reached a rare and incredible milestone for a modern healthcare proposal, earning the active support of a bipartisan majority of members in both the U.S. House of Representatives and Senate. These strong bipartisan endorsements represent the full diversity of constituent demographics and political ideologies. Support from lawmakers within Congressional committees of jurisdiction is even more sweeping: 77% of Ways and Means members, 63% of Energy and Commerce members, and 70% of Senate Finance Committee members have co-sponsored meaningful, equitable, and timely access to transformational advancements in cancer screening technology.

This level of forceful support is a recognition of the incredible burden of cancer across America, and the unmet need in earlier detection. The number of policies that enjoy this kind of bipartisan, bicameral, and expert community support are few and far between. H.R. 2407/S. 2085 is not only common sense, but it is the kind of policy that American's send lawmakers to Washington to advance. It is forward thinking, ensuring that policy is aligned with scientific innovation, while at the same time based on clear Congressional precedent. Your action on this bill is a unique and urgent opportunity to make a lasting impact on cancer care and quality of life.
