






## **2025 Washington State Legislative Priorities**

Victory in the fight against cancer requires bold public policy solutions that promote cancer prevention, increase early detection of cancer, expand access to quality, affordable health care, reduce disparities and advance health equity. These fact and evidenced-based priorities include:

#### **Expanding Access to Care**

 Access to Biomarker Testing – HB 1062: ACS CAN will advocate for improved coverage of comprehensive biomarker testing. Progress in improving cancer outcomes increasingly involves the use of precision medicine, which uses information about a person's own genes or proteins to better diagnose and treat diseases like cancer. Biomarker testing is an important step to accessing precision medicine which includes targeted therapies that can lead to improved survivorship and better quality of life for cancer patients, but insurance coverage for biomarker testing is failing to keep pace with innovations and advancements in treatment. Washington is falling behind. Twenty states – including California, Arizona, New York, Texas and Minnesota have enacted similar legislation to expand coverage of biomarker testing across disease types with strong bipartisan support.

**Fertility Preservation** – **HB 1129/SB 5121:** Some cancer treatments can cause infertility, and as a result, individuals with cancer may choose to preserve their fertility prior to treatment. Failure to preserve fertility is a common regret that may affect survivors' quality of life. ACS CAN supports legislation that would provide cancer patients with health insurance coverage for fertility preservation consistent with recommended medical guidelines.

**Reduce the Burden of Patient Medical Debt – HB 1632/SB 5480:** ACS CAN recognizes the impact of medical debt on people with cancer, caregivers and their families. In addition to supporting policies that ensure affordable access to comprehensive healthcare coverage, ACS CAN will advocate for policies that prevent the occurrence of medical debt and reduce the impact of incurred medical debt on individuals and families.

#### **Cancer Prevention and Early Detection**

 Breast and Cervical Cancer: ACS CAN will advocate to maintain and protect funding of The Washington State Breast, Cervical, and Colon Health Program (BCCHP) for low-income uninsured and underinsured women administered by the Washington Department of Health.

### **Reducing the Toll of Tobacco**

- **Tobacco Prevention and Cessation Funding** ACS CAN will advocate to maintain program funding for fact-based, statewide tobacco prevention and cessation programs at maintenance levels, only a percentage of the CDC recommended funding levels of \$63 million for Washington state. This program prevents kids from starting to use tobacco and helps those who are trying to quit.
  - End the Sale of Menthol Cigarettes and All Other Flavored Tobacco Products HB 1203/SB 5183: ACS CAN supports legislation to end the sale of menthol cigarettes and all other flavored tobacco products. Comprehensive policies to end the sale of flavored tobacco products must include all tobacco products, all flavors, and all tobacco retailers.

### **Cancer Research Funding**

•

**Research Appropriations**: ACS CAN will work to protect/increase appropriations to support scientific research on cutting-edge treatments, including fully **funding the Andy Hill Cancer Research Endowment (CARE) Fund to the statutory maximum of \$22.2 million annually.** 

### **Addressing Food Insecurity**

Increasing Access to School Meals – HB 1404/SB 5352: School meals offer students a variety of fruits and vegetables, whole grains, and age-appropriate portion sizes and may be the only nutritious meals many children eat during the day. Research suggests healthy eating pattern is associated with a reduced risk of cancer in adults. ACS CAN advocates for policies that support increasing access to free school meals to reduce food insecurity and improve diet quality.

## **Expand Biomarker Testing Coverage**

#### Will you support HB 1062?

- Timely access to guideline-indicated comprehensive biomarker testing can help **achieve the triple aim of health care including better health outcomes, improved quality of life, and reduced costs**
- Studies show that paying upfront for comprehensive testing **can result in overall savings in treatment costs**
- Washington is a leader in cancer research. Don't let us fall behind in access to cancer care
- Similar, disease-agnostic legislation has been signed into law in 20 states. In states where this policy is currently in effect, like Arizona, Illinois, Texas and California, none have reported challenges with costs for implementation, including for Medicaid populations


THE RIGHT TREATMENT AT THE RIGHT TIME

### WHAT IS BIOMARKER TESTING?

Biomarker testing is often used to help determine the best treatment for a patient.

- It is the analysis of a patient's tissue, blood, or other biospecimen for the presence of a biomarker.
- Biomarker testing is an important step for accessing precision medicine, including targeted therapies that can lead to improved survivorship and better quality of life for cancer patients.
- While most current applications of biomarker testing are in oncology and autoimmune disease, there is research underway to benefit patients with other conditions including heart disease, Alzheimer's disease, and other neurological conditions, rare disease, infectious disease and respiratory illness.

### THE IMPORTANCE OF BIOMARKER TESTING



### **BIOMARKER TESTING & HEALTH EQUITY**

- Not all communities in Washington are benefiting from the latest advancements in biomarker testing and precision medicine.
  - Patients who are older, Black, uninsured or Medicaid-insured, are less likely to be tested for certain guideline-indicated biomarkers.
  - There are lower rates of testing in community settings versus academic medical centers.

### THE BOTTOM LINE

# Access to appropriate biomarker testing may help to achieve:

- better health outcomes
- improved quality of life
- reduced costs

Insurance coverage for bioma rker testing is failing to keep pace with innovation and advancement in treatment.

Without action, this could increase existing disparities in health outcomes by race,

ethnicity, income and geography.

Twenty states have recently passed legislation to expand coverage of comprehensive biomarker testing.

### WHAT DOES THE BILL DO?

Ends the retail sale of flavored tobacco and nicotine products, including flavored e-cigarettes, pouches, chew, and menthol cigarettes beginning in 2026.

## INDUSTRY TARGETING HAS CONTRIBUTED TO SIGNIFICANT HEALTH DISPARITIES



#### Since the 1950s

The tobacco industry has aggressively targeted communities of color with menthol flavored cigarettes. 88% of Black smokers use menthol cigarettes.



**Menthol flavored cigarettes** Menthol cigarettes are easier for kids to start smoking, more addictive, and harder to quit.



#### **Flavors hook kids**

Nearly 90% of youth e-cigarette users use flavored products, and 50% of youth who have tried smoking started with menthol cigarettes.




#### American Indian/Alaskan Native Youth



# THE ANATOMY OF "SMART" E-CIGARETTES

#### The bill ends the retail sale of e-cigarettes with gaming or entertainment features



Digital screen indicates battery power and remaining e-liquid.

Some products have a switch to change battery power, allowing for bigger puffs and greater nicotine delivery.



Games can keep people on the device for long periods. Some devices require users to take puffs to maintain game play.

E-cigarettes can mimic small gaming devices, making them easy to hide in plain sight.



# SB5480/HB1632 - Shield Patients from Unfair Medical Debt Reporting

### **Protect Washington Patients from Being Trapped by Medical Debt**



**3 in 10 Washington residents say they live in a household with medical debt**, even with health insurance.



**29% of Washingtonians have a lower credit score** because of medical debt. In fact, almost 1 in 4 is contacted by a debt collector because of their medical debt.

#### Patient Experience

# Support SB 5480 (Riccelli) & HB 1632 (Timmons)

# Prohibit the inclusion of medical debt on consumer credit reports and scores.

Removing medical debt from a credit score improves a score by 20 points, on average.

Medical debt has no bearing on whether a person makes sound financial decisions and should not be used in consumer financial credit reports.

# Hook, Line, and Sinker



# The hook, line and sinker strategy will help ensure you cover key messages and conduct an effective and successful meeting with your lawmaker.

### Hook: Who You Are

Tell them who you are. Remember, you are a voter, a survivor/caregiver/advocate and their constituent. Make sure everyone in the group introduces themselves. Be careful. A little small talk is acceptable but stay on message and don't be drawn into storytelling off topic – you'll never know where the time went!

State why you are here by introducing the ask/s.

### Line: Share your stories and statistics

Be informative, be thorough and be concise. Provide your lawmaker with personal stories. They'll appreciate real-life examples that put a human face on the issue. Discuss how the legislation will directly affect you, your friends and your family. Personal stories truly make an impact and achieve results.

### **Sinker: The Request**

Ask your legislator their position on the issue. Be polite, direct and specific. Wait for their response. It is important to get a clear answer to provide on your report back form.

Answer any questions to the best of your ability. If you don't know the answer, it's OK to say "that's a good question, I'm not positive on the answer, and I'll need to get back to you." Don't answer any questions you're not 100% sure you know the answer to – make sure to list them on your report back forms. This is an excellent opportunity for staff to follow-up with the lawmaker after our day!

Leave on a positive note. As you wrap up the conversation, repeat one last time what action you hope the lawmaker will support. Make sure your lawmaker and/or their staff member receives a copy of the leave-behind materials. Thank them for their time and offer to be an ongoing resource.

# Lawmaker Meetings: Suggested Script



"Thank you, Representative/Senator \_\_\_\_\_, for taking the time to meet with your cancer-fighting constituents today.

My name is \_\_\_\_\_ and I am an ACS CAN volunteer from \_\_\_\_. With me are constituents and advocates from around your district to talk about their cancer stories. **Introduce** constituent(s) in the room with you.

During this meeting we would like to discuss:

#### • Biomarker Testing Coverage with HB 1062

#### Share 1 Fact That Sticks Out to You:

- Biomarker testing has been shown to be a cost-effective tool to get patients the right treatment at the right time.
- We must work to dismantle barriers that prevent patients from benefiting from biomarker testing and precision medicine. A 2022 study published by the Journal of Precision Medicine found that 55% of covered lives in Washington currently do not have comprehensive coverage.
- Washington is falling behind, biomarker testing coverage has now passed with strong bipartisan support in 20 states!

This is important to me because (share your personal story and connect it to the importance of Biomarker Testing Coverage). If another volunteer has a personal story that has a strong connection, please introduce them and have them speak. Keep it brief.

#### The ASK:

#### • Will you support, and vote yes, on HB 1062?

Remember, we want to hear a yes or no answer.

- If your elected official answers yes to this question that is great! Thank him/her for their support.
- If your member answers no, ask why and if there is further information you can provide after the meeting. Include that information on your report back form.
- If your member doesn't give a direct yes or no answer, ask for clarification.
- You should plan to follow-up with your House Representative 1-2 weeks after your meeting (by phone or email) to ensure their questions are answered and check on their level of support.

<u>Please note:</u> this script is a framework for your conversation. Please feel free to elaborate and share your personal cancer story and use information from the fact sheet and talking points.

# Lawmaker Meeting: Do & Don't



#### Do:

Look and act professional

Introduce yourself and tell the legislator where you are from

Stay on message

Be prepared to wait

Know the asks and something about it

Be efficient and articulate; the meeting should be brief and concise

Ask for your legislator's support for the issue

Stop discussing the issue if you get a "Yes"

Leave a one-pager about the issue

Turn off your cell phone

Thank the lawmaker (be sure to also send a thank-you note)

#### Don't:

Attempt to answer questions you don't know the answer to or commit to anything you aren't certain of

Get angry or hostile

Get distracted by small talk

Mention your political affiliation

Leave behind materials that aren't provided in this packet

Lobby on other issues while you are there to talk about cancer

Get defensive if an elected official doesn't support our legislation



- Post an accompanying action alert for your campaign on your social media channels.


### **After Event**
